The membership fee must be paid in full at the start of this contract and monthly payments must be made by the 15<sup>th</sup> of the month to participate. This contract will terminate on the 16<sup>th</sup> of the month if not paid in full and all rights included in membership to Water Oak Aikikai will be cancelled. To reinstate this contract 2 months dues must be paid for in full. In partnership with Sparks' Martial Arts, Water Oak Aikikai students in good standing may attend Aikido classes at Sparks' Martial Arts as part of this membership, but it does not entitle the member to any additional classes or arts at Sparks' Martial Arts.

**Promise to pay:** The undersigned promises to execute the payment schedule stated above. We waive any security of interest of lien which may arise by operation of law, except the lien of any judgment which we may obtain if this contract is not paid in accordance with its terms.

**Restrictions/cancellation or assignment:** This membership is nontransferable, non-assignable and non-refundable. You may cancel this contract by notifying Water Oak Aikikai in writing by the 15<sup>th</sup> of the month.

### Terms and Conditions

**Law Applicable:** Federal law governs the contract.

**Invalid provisions:** If any part of this contract is found to be invalid or unenforceable, the remainder of the contract will be valid and enforceable.

**Entire agreement:** This contract comprises the entire agreement pertaining to membership and no other agreement of any kind, verbal understanding or promises whatsoever will be recognized or binding on us.

**Signers of the Agreement:** It is your responsibility to know whether this contract is in default or that payments have been missed. We are not responsible for notifying you of late payments or any default procedures.

**Assumption of Risk:** The applicant's desire to participate in the study of the art of Aikido at Water Oak Aikikai or Sparks' Martial Arts notwithstanding his/her awareness of the possibility of incurring physical injury in the course of such study of said art. The applicant, in consideration of being accepted as a participant in such study by Water Oak Aikikai, hereby assumes all risk of personal injury (whether anticipated or unanticipated) resulting from his/her participation.

The applicant hereby agrees to hold Water Oak Aikikai, its officers, instructors, and agents harmless from any liability resulting from the study and practice of said art. The applicant further agrees to bind himself/herself, his/her heirs, administrators and executors to repay and indemnify the above named Water Oak Aikikai any sums of money the center, its officers, instructors and agents may hereafter become liable to pay on behalf of the applicant for any reason whatsoever.
